## **Ethics Update**

Nicole Heimarck gave an update on House Bill 210, code of Ethics for certified educational personnel. "This bill authorizes the state board of education to adopt rules establishing a code of ethics for certified educational personnel" <u>https://legiscan.com/NH/text/HB210/id/1441954</u>

Commissioner's taskforce has been working with the legislature on removing "enforcement" from the Code of Ethics as well as replacing the word "teacher" with "educator". Information regarding Code of Conduct was also shared and the difference between the two codes. Suzanne Canali reiterated there is confusion between Code of Ethics and Code of Conduct. Mike Fournier mentioned this would mean fewer people in a school would follow this Code of Ethics as it would only apply to certified teachers, and discussion followed regarding implementation challenges.

## Diana Fenton 1:45-2:30- discussion of proposed edits to criminal records checks

Diana Fenton, Attorney, NH DOE gave an overview of what she has been working on since her last visit to this group. "TITLE XV EDUCATION CHAPTER 189 SCHOOL BOARDS, SUPERINTENDENTS, TEACHERS, AND TRUANT OFFICERS; SCHOOL CENSUS School Boards, Transportation and Instruction of Pupils Section 189:13-a School Employee and Designated School Volunteer Criminal History Records Check" http://www.gencourt.state.nh.us/rsa/html/xv/189/189-13-a.htm

A copy of the proposed changes to RSA 189:13a was provided. As a procedural note these changes will not go forward as their own bill, the changes would be added as an amendment to another bill. If it is not ready for this session it will go on to the next. Much discussion followed, with many clarifying questions around implementation. Colleges will need to start looking at their policies now. How will this increase the work load for SAU HR staff? Student teachers may only have one semester in a school, and the HR person will have to get the record check done before the student can begin the semester. Will it make SAUs not want to take on student teachers? Concern for the cost college students will incur was also raised. Also discussed privacy issues, and reciprocity with New England states especially MA.

It was suggested Diana might want to work with the NH School Administrators for their input, and other states such as Pennsylvania put the responsibility on the student teacher by issuing a certificate they can use for one year. Nicole suggested this issue could be outlines specifically in partnership agreements and MOUs between SAUs/p-12 schools and Colleges wanting to place student teachers.

Diana will check into waivers so the cost will not escalate too high for college students.

Laura Wasielewski asked what would be the next steps. Diana is looking for more feedback. She will reach out to DHHS and School Administrators.

### Frank Edelblut, Commissioner, NH DOE 2:30-3:00

The new commissioner, Frank Edelblut, arrived and Laura asked the members to introduce themselves with their organization and role. The commissioner spoke about personalized education and shared a story of one of his son's educational journey starting with struggling to read as a child, home schooling, moving on to complete college, and beginning his career with Google.
